The Clinton Health Access Initiative (CHAI) seeks interested and capable vendors to submit quotations for the supply and installation of a medical oxygen piping distribution inclusive of a manifold system for the **Louangphabang Provincial Hospital** as detailed in the specification package (Annex A) of this RFP. At present, the hospital is utilizing bedside oxygen cylinders as the medical gas pipeline network is inoperative since the last few years owing to certain leakages and broken lines across wards/departments. Appropriate installation and repair of oxygen outlets and the pipelines will allow the hospital to expand its capacity to care for patients.

When preparing your RFP please be guided by the form attached as Annex B and CHAI code of conduct and ethics for suppliers in Annex C.
